

## Comparison of Iran Internet Freedom Legislative Measures

The Internet Reach and Access Now (IRAN) Act and the Iran Human Rights, Internet Freedom, and Accountability Act introduced in the House and Senate represent complementary congressional efforts to strengthen internet freedom, support Iranian civil society, and respond to the Iranian regime’s use of nationwide internet shutdowns to suppress dissent and conceal human rights abuses.

The IRAN Act focuses on improving coordination across the U.S. government by designating the Department of State as the lead agency responsible for implementing and updating a comprehensive strategy to expand secure connectivity tools such as VPNs and direct-to-cell communications, while protecting satellite coverage from intentional disruption and supporting cybersecurity programs for civil society. It authorizes \$15 million annually for FY27–28 to support cybersecurity training and digital safety tools, including programs that expand access to secure VPN services for individuals in Iran.

The House version of the Iran Human Rights, Internet Freedom, and Accountability Act builds on this objective by expanding technical analysis requirements, increasing and extending funding authorization for the Iran Internet Freedom Grant Program to \$30M for FY27-30, and directing the Defense Innovation Unit to develop technologies capable of countering shutdowns. It also includes broader human rights and corruption accountability provisions, most notably establishing an Iran Kleptocracy Initiative within the Treasury Department to identify and disrupt corruption networks tied to regime officials and requiring presidential determinations on human rights sanctionable actors.

The Senate version incorporates several coordination elements aligned with the IRAN Act while maintaining the broader framework of the House bill. It increases and extends grant program funding at not less than \$20 million annually for FY27–30, and establishes an interagency working group to support the development and deployment of shutdown-circumvention technologies, while expanding cybersecurity training and broadcasting support.

Together, the three measures reflect overlapping but distinct approaches to advancing internet freedom, strengthening resilience against shutdowns, and promoting accountability for repression in Iran.
